

Monday's Meeting September 14, 2015:

Sharon Kennedy—The 4 Way Test



Court Justice Sharon Kennedy's presentation is titled "The Rotary Four-Way Test and the Founding of America." She will be discussing the parallels found between the Rotarian code of ethics and the principles that guided the founding fathers as they established a new nation and government.

Ohio Supreme Court Justice Sharon L. Kennedy began her career in the justice system as an officer for the City of Hamilton Police Department. Following her time on the police force, Justice Kennedy obtained her law degree from the University of Cincinnati College of Law and entered the legal field as a solo practitioner.

During her time in private practice, she also served as part-time magistrate in the Butler County Area Courts, as well as special counsel for former Ohio Attorney General Betty D. Montgomery. She was elected to the Butler County Court of Common Pleas Domestic Relations Division in 1999, where she also served as the administrative judge from 2005 until her election to the Supreme Court in 2012.

Justice Kennedy has been the recipient of multiple awards, including the Nicholas Longworth, III Alumni Achievement Award, which she received from the University of Cincinnati College of Law on May 17, 2014. She was named one of 13 professional women to watch by the Cincinnati Enquirer in March 2013, and was named Judge of the Year in 2006. On December 7, 2012, Justice Kennedy was sworn in as the 154th Justice of the Supreme Court of Ohio and the ninth female justice to serve on the court.

Mike O'Brien—The Economics of 1-A Athletics

Mike O'Brien, UT vice president and athletic director,



began by presenting an overview of UT which has current enrollment of 21,000 undergraduate and graduate students and over 140,000 living alumni. UT offers over 300 programs and is now a "destination school" for a lot of students. UT competes in the Mid-American Conference (MAC) is in the Group of 5 Conferences which is the less

prestigious conference group versus the Power 5 (ACC, Big 10, SEC, Pac 12, and Big 12). UT is trying to keep pace in its student-athlete financial offerings with the bigger schools but isn't able to do everything because of costs. At UT, not all student-athletes are on scholarships and most teams must divide a scholarship among many students. These teams offer full scholarships—football, men's & women's basketball, women's volleyball, and women's tennis. UT has 340 student-athletes and 300 are on some kind of scholarship. Mike discussed how television has changed game attendance. UT athletics has had to be creative to generate community and fan support to fill the Glass Bowl. Games being seen on ESPN pay off in increased exposure across the country. Mike then addressed pay for play which would be detrimental to schools because of the budget implications. Since 2010, 15 schools have dropped 66 sports because of money issues. Mr. O'Brien said that would only increase if schools were mandated to pay student-athletes and could result in funding changes to things like the Olympics as well as student support services being affected. UT's goal is for all student-athletes to grab their diplomas with a championship ring on a finger. Mike proudly announced that UT student-athletes earned a 3.255 overall GPA in the spring 2015 semester and that all of the 16 UT sports teams earned a 3 or above GPA for the first time in school history. Way to go Rockets!

Scot Hinshaw is with Niehaus, Wise and Kalas where he




specializes in employment law and commercial litigation. Scot has also served as an instructor at the Georgetown University Law Center. He is a member of the American Bar Association and is




