

# Monday's Meeting November 16, 2015: Joe Napoli—Hensville: A New Downtown Toledo Destination

Joe Napoli, president & CEO of Toledo Mud Hens



Baseball Club, Toledo Walleye Hockey Club, and Hensville will discuss the progress and impact of this new downtown destination. Born and raised in Brooklyn, New York, Joe graduated from St. John's University in New York City. Upon graduation, he joined Manufacturer's Hanover Trust in New York City. After a brief career in banking, Joe's twentyfive year career in sports began in

Canton Ohio, with the Canton Indians. In the early 90's, he moved to Toledo to work for the Toledo Mud Hens before spending several years working for the Chicago Bulls and Detroit Tigers. Joe returned to Toledo to embark on the development of Fifth Third Field in downtown Toledo. Years later, a second opportunity presented itself, and he became part of the development team for the Toledo Walleye and Huntington Center. In 2012, the Hens initiated efforts to begin the downtown Toledo re-development of three historic buildings and park space which will become known as "Hensville." According to Nielsen Scarborough Research, the Hens and Walleye continue to rank amongst the most popular franchises in Major and Minor League sports. Sports Business Journal selected Toledo as the #1, now #2, Market in America for Minor League sports. Both the Hens and Walleye have been recognized and awarded for organizational excellence by Minor League Baseball and Minor League Hockey. Joe met his wife, Annette, in Toledo during his first stint with the Mud Hens. Annette and Joe love raising their five children in Toledo.

# Chris Cooper—The ProMedica Affiliation and What it Means for the Community



Dr. Chris Cooper described the affiliation between the University of Toledo Medical Center and ProMedica. In academic medicine, a critical relationship exists between a college of medicine, a hospital, and a faculty physician group practice; each part relies on the other to achieve its mission. Academic medicine makes care better for

all. UTMC cannot finance all of the needs of the College of Medicine. Doing so would accelerate a downward spiral. So, the College of Medicine needs significant capital over the next decade to achieve its mission. UTMC needs a partner to sustain its long-term academic objectives. UTMC has a class size of 175 and one of the smallest faculties of academic hospitals in the country. With the 50-year affiliation agreement, UTMC students will have access to more patients, larger and more diverse faculty, more patients for faculty, increase in funded research, and additional resources to the College of Medicine to support recruiting additional faculty. The affiliation will have shared governance through the Academic Affiliation Operating Group. ProMedica has agreed to provide support of \$50 million per year. In capital support, ProMedica will spend \$100 million by 2027 and \$150 million after year 12 to upgrade and construct new buildings on the ProMedica and UTMC campuses. UTMC worked with the Ohio Attorney General's Antirust Division to make sure there were no issues. Dr. Cooper stated that this partnership is guided by shared interests: train the next generation of healthcare professionals, create knowledge through biomedical research, and high quality patient centered care. He concluded that the affiliation allows the aggregation of two strong entities and that the partnership with ProMedica builds on the foundation created by prior leaders and creates a stronger community.
