



Monday's Meeting: June 11, 2018 Judy Leb & Demecia Wilson Lucas County Juvenile Court



For nearly a decade the Lucas County Juvenile Court has strived to lower youth incarceration and become more sensitive to the issue of disproportionate minority contact. Through multiple initiatives, LCJC has become a leader in juvenile justice reform. From detention reform to the development of the Assessment Center and transforming juvenile probation, LCJC continues to build upon its efforts to decrease youth incarceration for low-level offenders.

Demecia M. Wilson, Administrator of Juvenile Probation and Assessment Center Services at the Lucas County Juvenile Court, has dedicated the last twenty three years to serving youth and families. Demecia and her team continues to lead the charge in probation transformation and reform in Lucas County. From the implementation of the Balance and Restorative Justice approach to supervision, to embracing the Juvenile Detention Alternatives Initiative (JDAI) framework, along with a plethora of other initiatives Demecia has been at the forefront working diligently to positively impact change.

Her commitment to juvenile justice and reform is what motivates her, but her dedication to helping to improve the lives of youth and families is what strengthens her to do this work on a daily basis.

Judy Leb is the Director of Lucas County CASA (Court Appointed Special Advocates), a non-profit organization of volunteers who work for the juvenile court judges to help abused and neglected children find safe and permanent homes.

225th Anniversary of the Battle of Fallen Timbers



Fallen Timbers is the third most important battle site in the US. It was the first successful US battle against the Natives and the last chance to open western lands to settlement. The Toledo Metroparks made an agreement with stakeholders to manage the 3 sites that commemorate the battle: the Fallen Timbers Monument, Fallen Timbers Battlefield Park and Fort Miamis. 2019 marks the 225th anniversary of the battle, which happened for a few reasons. Washington needed to sell the western lands because of the huge debt from the Revolutionary War and America needed to show the world it could protect all of its territory. Although it wasn't the biggest or most devastating battle, the results made it one of the most important battles. The site of the Battle of Fallen Timbers was believed to be somewhere else, until 1995, when an archaeologist discovered the actual battlefield. In 2000, the Metroparks agreed to purchase 187 acres to preserve the site from development, and created the Fallen Timbers Battlefield and Fort Miamis National Historic site. In 2015, on the 20th anniversary of the battlefield preservation, it was opened to the public for the first time. The historical sites are continually being improved to increase visitors and have a bigger economic impact. The 225th anniversary will be a year long celebration leading to the anniversary week, Julia said. It will be a national/international event, bringing people from all over the world together to celebrate.
