Polio: where we are now

(Published in the October issue of The Rotarian Magazine)

President elect, Tim Ryan, gave an update on polio at the October 1 meeting. This year to date, in the whole world, there are 18 cases of Polio. The only 3 countries with cases are Pakistan, Afghanistan and Nigeria. Despite the progress we have achieved, as long as a single child remains infected, children in all countries are at risk of contracting the disease. The poliovirus can easily be imported into a polio-free country and can spread rapidly. The failure to eradicate polio could result in as many as 200,000 new cases every year, within 10 years.

The Rotarian magazine featured an article on polio, and where we are on the quest for eradication. As printed in the October issue:

As the number of polio cases approaches zero, the challenges facing Rotary and its partners in the Global Polio Eradication Initiative are changing. We still need to reach every child with the polio vaccine – and we’re using innovative strategies to do that, in spite of geopolitical uncertainties.

But that’s only one part of our job.

We’re tackling vaccine-derived poliovirus, which can begin to spread in places where vaccine coverage is low. We’re becoming disease detectives, following up on any shred of evidence that wild poliovirus might still be circulating. And we’re fine-tuning our plan to keep the world free of polio forever.

Here’s what you need to know about where we are now.

Polio is an intestinal virus that is spread through contact with the feces of an infected person, which can contaminate water or food.

- 1. The virus latches onto a receptor on the surface of a cell, multiplying in the lining of the intestines.*
- 2. It enters the cell and hijacks the cell’s own machinery to make copies of itself.*
- 3. The virus is released to infect neighboring cells, spreading from the digestive tract to lymph nodes and the bloodstream.*
- 4. The virus replicates and is excreted through feces, starting the cycle again.*

Rotary and its partners worked to reach 430 million children in 39 countries during polio immunization campaigns in 2017.

You are Invited: 18th Annual Great Lakes Water Conference

Friday, November 2
University of Toledo College of Law

Titled "Regional Water and More," the conference will feature three panels of law and policy experts. One panel will concentrate on Ohio, including a possible regional approach to drinking water among the city of Toledo and nearby communities. A second panel will discuss the trend toward regionalization of water and sewer systems beyond the Buckeye State, including the new regional authority in the Detroit area. A third panel will address the rights of recreational paddlers versus private landowners, developments in the legal fight against algae in Lake Erie, and regulation of discharges of pollutants to groundwater under the federal Clean Water Act.

Darren Nichols, executive director of the Great Lakes Commission, will be the keynote speaker. The conference is sponsored by the College of Law and its Legal Institute of the Great Lakes.



TSA Update



Doug Mead, Director for TSA, said this is the beginning of their 20th anniversary season and believes they are one of the most successful charter schools in the country. As a charter school, they are open to any resident in the state of Ohio. They currently house over 700 students from over 25 different districts, serving grades 6-12, and employ over 90 faculty and staff. TSA is engaged in over 150 events a year, making them one of the premier providers of arts & culture in the Toledo area. They believe that academic and arts education are not mutually exclusive. TSA has received several accolades over the past several years, including being rated the top charter school in Ohio (twice), a governors award for innovation, and rated as one of the top college prep schools in the state. They believe arts education allows students to connect better with the material in the classroom. David Saygers, artistic director, said there are 5 broad disciplines for the students to study—music, dance, theatre, visual arts and creative writing, however, all of their academic studies take place at TSA as well. They strive for the highest possible quality and some of their students even work at a professional level. TSA believes that expectations drive accomplishment, expecting their students to work at the very highest levels. Students regularly perform throughout the community—providing the dual opportunities of authentic experience, as well as increasing the school’s visibility. The school has partnerships with the Toledo Museum of Art, where students work as teen apprentices, as well as with the Toledo Symphony. The arts are even integrated into the regular academic lesson plans. Dave Gierke, director of development, thanked the Club for our support to TSA over the years. Our Club allowed them to purchase their first PA system, which enables them to go out and perform. TSA has also been able to purchase multiple musical instruments, theatre and other art equipment with the funds granted to them. For the future of TSA, they are hoping to break ground on an addition on to the back of their existing building within the next 3 years. The idea is to create a community portal where they could have a showroom, have a retail store to sell the students artwork, as well as increase their space and make it safer for the students.
