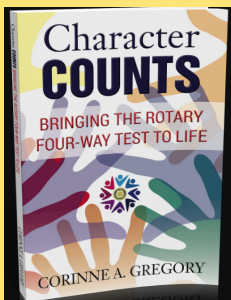
**CORINNE GREGORY**

Corinne Gregory is an author, speaker, award-winning educator and the President and Founder of The PoliteChild®, creator of SocialSmarts™.

After 20 years in the technology and business sectors, Corinne felt that the next phase of her life needed to be spent making the world a better place, especially for our children and for future generations. The PoliteChild was born out of Corinne's belief that our society needs to return to a more civilized and kinder way of interacting with one another.



Instead of simply whining with others about the decline in values and behavior, Corinne decided to do something about it. She developed the SocialSmarts program in the hopes of making a difference in the lives of children and families by giving them the tools to help them truly succeed not only in school, but in life: the gift of good social skills.

Corinne is a frequent advisor and spokesperson on education and family-development topics. Her media appearances include The Today Show, CNN, Time Magazine, USA Today, The Washington Post, The Wall Street Journal, Parents Magazine, and more. Because of her work with Rotary and her adaptation of the 4-Way Test in the SocialSmarts curriculum, Corinne and the program were featured in Rotarian Magazine's February 2010 issue. Besides her previously published technology and business-focused books, she is working on several books related to the SocialSmarts program, parenting, and education reform, including the highly acclaimed "It's Not Who You Know, It's How You Treat Them: Five SocialSmarts® Secrets Today's Business Leaders Need to Stand Out and be Successful." Her most recent book is "Character Counts: Bringing the Rotary Four-Way Test to Life."

Married with three daughters, she's a fellow Rotarian, formerly with the Woodinville Rotary and Redmond Rotary, but now with East Jefferson Rotary in Chimacum, WA. She has spoken to Rotary Clubs nationally and internationally, including a presentation at the 2019 Rotary International Convention in Hamburg. She was also recently invited to participate on the Board of the Ethics Fellowship of Rotary (EFOR).

Heather explained how the white paper looks at how many nonprofits are in the area and who they are serving and most importantly, measuring the efforts of our community investment for particular causes. The Center is a program of the Greater Toledo Community Foundation, founded with the commitment of ensuring nonprofit organizations deepen their impact with the information and resources required to operate in an efficient and effective manner. Heather oversees and delivers support in the areas of professional development, technical assistance, multiple certificate programs, on-demand resources and engagement. She also serves as the Grant Officer for the Strategic Alliance Partnership Grant which was created to support the exploration and formation of collaborations that would enable Toledo area nonprofits to achieve more efficient use of financial and human resources. The Strategic Alliance Partnership encourages community-level systems thinking to strengthen nonprofit capacity and improve service delivery.

Heather holds a BA in Psychology and is a board certified coach. As published author, she is credited with four books, dozens of articles and a collection of on-line courses. Heather is an avid figure skating fan and was named as a fan blogger by the US Figure Skating Association. Heather lives in Old Orchard with my husband Gary and our two rescue kitties, Mr. B and Jay. Heather is an avid Indy Car fan.

## In Memory of Rotarian Thomas A. Klein



Thomas A. Klein, a professor emeritus of marketing at the University of Toledo where he became the acting dean for what now is the College of Business and Innovation, died Thursday at Ebeid Hospice Residence, Sylvania. He was 84. He died of kidney failure, said his wife of 58 years, Karen Klein.

Klein, who held a doctorate from Ohio State University, retired in 1993 from the University of Toledo College of Business Administration, where he taught marketing and most recently was acting dean in the 1980s and early 1990s. Before serving as acting dean, Mr. Klein was associate dean for many years and directed the UT Business Research Center.

During his early years at UT's business school, Mr. Klein taught research methodology to postgraduate students. His research focus at the time was on statistics and marketing.

During the late 1960s Mr. Klein was a member of the Toledo Mayor's Advisory Committee on Retail and Wholesale Markets and of the Model City Employment and Evaluation Committee, serving as a liaison with the city of Toledo to help implement Toledo's Model Cities program where he helped establish the Toledo Farmers' Market. He was named one of Toledo's 10 outstanding young men for 1968 by the Toledo Area Junior Chamber of Commerce.

Later in his career, Mr. Klein wrote two books and multiple articles on business ethics. In 2013, he received the Macro Marketing Association Award for his scholarly contributions to the field. In retirement Mr. Klein taught business ethics at the University of Notre Dame for a time and then returned to UT for two more years, during which he helped establish a business ethics program and was instrumental in instituting the Center for Family Business and the sales program. He was a past national chairman of the subcommittee on minority entrepreneurship of the American Marketing Association and a past board chairman of the University Branch YMCA. Over the years, he had also served on the boards of the University of Dayton, Toledo Rotary, the Diocesan Catholic Schools, and Toledo Opera.

Born May 16, 1936, in Toledo to Adeline and Arnold Klein, Mr. Klein graduated from Central Catholic High School in 1954, then obtained a bachelor's degree from the University of Dayton, a master of business administration degree from the University of Detroit, and a doctorate from Ohio State University. After receiving his doctorate in 1964, Mr. Klein joined the UT College of Business faculty as an assistant professor of marketing and statistics. In a couple of years, he became an associate professor and then a full professor a few years later.

In his free time, Mr. Klein liked to cheer for his children and grandchildren at their sporting events and go to concerts, art museums, and theater performances. Mr. Klein also enjoyed traveling, camping, playing tennis, dining out, and hosting dinner parties. His memberships included Toledo Rotary and the Toledo Club.

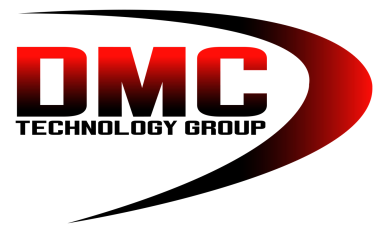
