

# Monday's Meeting February 1, 2016: Mordechai Kedar: Middle East

Dr. Mordechai Kedar will talk about the Middle East and



where it is heading including the source of problems and struggles and some ideas about the way to solve them. Dr. Kedar is a renown Israeli scholar of Arabic literature and a lecturer at Bar-Llan University where he holds a PhD. and is director of the Center for the Study of the Middle East and Islam. He is an academic expert on the Israeli

Arab population. He served for twenty-five years in Israeli Defense Forces Military Intelligence, where he specialized in Islamic groups, the political discourse of Arab countries, the Arabic press and mass media, and the Syrian domestic arena. He served as a lieutenant colonel and head of a branch in the hi-tech 8200 unit and was on active duty until 1995. The Los Angeles Times' Edmund Sanders described him as "one of the few Arabic-speaking Israeli pundits seen on Arabic satellite channels defending Israel." Dr. Kedar is the author of many publications including Clash of Values: Gender and Family Issues as Sources of Tension Between Islam and the West and Assad in Search of Legitimacy: Messages and Rhetoric in the Syrian Press under Hafiz and Bashar.

#### Zuzanna Mleczak: Poland

Zuzanna Mleczak, the Club's Youth Exchange student



discussed her experiences here in Toledo and gave members an overview of her country, Poland. Zuza has been in the U.S. since August and is currently living with the Hawkins family in Maumee where she is attending school. When she attended the orientation, she didn't think anyone here would know

anything about or even where Poland was. Poland is the 9th largest country in Europe and is the size of New Mexico. The country which was founded in AD 966 is divided into 16 different regions and adopted the second constitution in the world (following the U.S.). Zuza shared that Poland has been in NATO since 1999 and in the European Union since 2004. She explained that the president of Poland has much less power than a U.S. president and that the Polish Parliament commands the power. Poland's flag consists of a white field atop a red field, and Zuza explained that private citizens are only allowed to fly the flag on certain holidays throughout the year. Many of the country's holidays revolve around religious celebrations and holy days. Zuza has studied many languages and explained that Polish is considered in the top 10 of most difficult to learn. She gave a tour of the holidays, customs, and food of her region. One custom which stood out is that Poles leave an empty place setting at their Christmas dinners in case a stranger should need a place. Zuza discussed that education, including college, is free in Poland and secondary education in the country ranks higher than in the U.S. Zuza described her city, Poznań, which has 500,000 citizens and is still rebuilding after being destroyed during World War II. She likes traveling and skiing and has found her education thus far in the U.S. easy. Zuza listed a few famous people from Poland: Frédéric Chopin (pianist), Madame Curie (scientist), Pope John Paul II, Lech Walesa (world leader), and Nicolaus Copernicus (scientist).




