## Monday's Meeting June 20, 2016: Dr. Michael A. Rees



Michael A. Rees, M.D., Ph.D., received his M.D. from the University of Michigan, completed a residency in Urology at the University of Virginia Health Sciences Center followed by a three-year fellowship in transplantation at the University of Cambridge in England. During this time, he trained in clinical transplantation in the Department of Surgery under Professor Sir

Roy Calne, and also completed the research for a Ph.D. degree in Immunology, and, more specifically, Xenotransplantation. He is board-certified by the American Board of Urology and has performed more than 700 renal transplants at the University of Toledo Medical Center, in Toledo, Ohio where he is the Director of Renal Transplantation.

Together with his father, Alan Rees, a computer programmer, Dr. Rees designed the first prototype of a computer program to match willing but incompatible donor and recipient pairs for transplantation through kidney paired donation in 2000. In the fall of 2006 he founded the Alliance for Paired Donation, a not-for-profit organization that now has 80 participating transplant centers in 30 U.S. states and has arranged transplants for more than 350 patients. In March 2009, Dr. Rees published a new concept in the New England Journal of Medicine introducing the strategy of Nonsimultaneous Extended Altruistic Donors, which has become the most common method of creating kidney paired donation (KPD) transplants in the United States. In 2012, Professor Alvin Roth was awarded the Nobel Prize in Economics in part for his work with Dr. Rees and the Alliance for Paired Donation creating kidney exchange algorithms. To recognize his contribution, Professor Roth invited Dr. Rees to join him in Stockholm for the award ceremony. Dr. Rees is currently supported by three U.S. Federal Grants to study KPD financing and new methods of histocompatibility typing and optimization to improve the selection of donor/recipient pairs in KPD. In January 2015, Dr. Rees helped to lead a team to complete the first Global Kidney Exchange transplant in which the mechanism of KPD was used to overcome the barrier of poverty.

## Past Program—June 13, 2016

**Dr. Anand Agarwal**

### A Center for Orthopedic Innovation?



Dr. Agarwal shared his vision for the City of Toledo to become an innovation center for orthopedic appliances and other medical production companies. His vision centers on several of the companies of which he is President and courting domestic and foreign investors and companies to make Toledo a hub for medical innovation.

Spinal Balance, Inc. features pedicle screws, used as spinal implants to reduce back pain, trauma and deformities. The product features a “touchless” system where the implant is never touched by human hands. Spinal Balance has 12 full-time employees and will be hiring 4–6 more soon.

Osteonovus produces NovoGro, a putty easily molded to fit and fill specific target areas of the pelvis, lumbar spine and other extremities. NovoGro is an injectable synthetic biomaterial which enhances bone growth. Osteonovus employs full-time staff of 8 and expects to hire 6–8 more in the last half of this year. NovoGro is projected to be launched late in 2016.

Intellisense, if funded, plans to employ 8–10 people.

Intellisense’s primary product is a sensor able to diagnose specific infections in fewer than 5 minutes. Current standards to diagnose similar infections can be 3 – 5 days. A prototype model of the sensor validated the ability to diagnose several bacterial and viral infections including MRSA, Ebola, HIV and E.Coli. Quick diagnosis leads to faster treatment which leads to quicker recovery. Expected product launch for Intellisense is 2018.

As with many start-up companies, funding and investment is critical to Dr. Agarwal’s dream. Major investors from Germany and France have expressed an interest in investing and establishing manufacturing facilities in Toledo.

Agarwal’s vision is to establish a medical technology park which would include manufacturing facilities, Research & Development and companies employing 200 – 400 people in high-paying, high-tech manufacturing and high-level research positions.

Similar centers of innovation exist in Warsaw, Indiana, Cleveland, Ohio and Memphis, Tennessee. Why not Toledo, Ohio?

## Congratulations Rotarians

Two members of the Rotary Club of Toledo recently announced their retirement after long careers in public-service.



Carol Bintz, a Toledo Rotarian since 2007, has retired as the Chief Operating Officer at the Toledo Museum of Art.

Serving almost 26 years at the museum, Bintz was named the 2016 Professional of the Year by the Ohio Museum Association.

Carol was responsible for construction of the museum's outdoor Sculpture Garden and the Glass Pavilion, which opened in 2006.

Bintz was also instrumental in the installation of solar panel systems which has reduced energy purchases by 90% and has saved about \$600,000 in 2014-15.

Carol hopes to travel, write and still be involved as a part-time consultant for the museum.

### FOUNDATION SERVICE COMMITTEES

#### OVERVIEW

The #1 responsibility of each of the foundation service committees is to review, process, and recommend grants submitted to the Toledo Rotary Foundation. Each Rotary year has three grant deadlines:

July 31, October 31, and March 31

Each service committee participates in the due diligence process of vetting each grant. Due diligence invites Club members to review the grant application to determine if it meets our mission as well as the foundation's grant giving criteria. Participation at this level offers an opportunity to truly experience and understand how member contributions impact our community and participate in determining where funds are directed. Committee members decide which grants meet the criteria for recommendation. Each service committee chair & vice chair presents committee recommendations to the FAC.

#### ☐ Community Service Committee

As a member of Community Service, you have an opportunity to participate in the review of grant requests from a broad section of our community. This committee meets 6-8 times/ year to review and discuss grant requests and projects impacting our local community. Non-profits we have supported in the past include the Cherry Street Mission, Sunshine, Habitat for Humanity, Toledo Ballet, Little Sisters of the Poor, Toledo Area Humane Society and many more. This committee spearheads annual service projects such as Salvation Army bell-ringers and a spring clean-up for Little Sisters of the Poor. Involvement with the Community Services Committee offers hands-on opportunities that make a difference right here in our own community.

#### ☐ Disability Service Committee

Committee members have an opportunity to participate in the long-history of our Club's focus and service of helping others maintain a relatively normal lifestyle, no matter what their ability. Our Club's long history with Glendale Feilbach elementary school and the Ability Center have created regularly promoted committee and club projects. Among them include a day at the Toledo Zoo and Toledo Museum of Art day at the Glass Pavilion. This committee manages all grant requests for any type of disability and meets 6-8 times/year. The Disability Service Committee studies the needs and challenges of the disabled community and recommends steps and procedures to provide solutions.

#### ☐ International Service Committee

The International Service Committee manages international grant requests and projects. International Service adopted three rural villages in Honduras with a commitment to long-term development in this area from our Club and holds 6-8 meetings per year. Using worldwide Rotary resources, this committee involves every member in advancing International understanding, goodwill, and peace. International Service Committee is connected with our Club's district 6600 through MESA (Medical Equipment Supplies Abroad), water projects, and more.

#### ☐ Vocational Service Committee

Vocational Service Committee members play an integral role in mentoring youth and adults in their respective vocations. Committee members focus on development of professions, trades, and education within the community's chosen vocations. As a Vocational Service Committee member, you will have an opportunity to review and manage grant requests for new and existing vocational programs; this committee has 6-8 meetings per year. Vocational Service provides an opportunity to showcase member career skills while participating in mentoring opportunities as well as the promotion & education of the application of the 4-way test in all vocations, at any age.

#### ☐ Youth Service Committee

The Youth Services Committee members have an opportunity to experience and manage multiple grant requests that impact the youth in our immediate area. Past Youth Service grant requests have come from Claire's Day, Toledo School for the Arts, Early Childhood Development & more. This committee will manage grant requests during each of the grant cycles, participate in site visits, and make recommendations to their committee for projects they feel will have the greatest impact, meeting 6-8 times during the year. The committee discovers the problems challenging young people, cooperates with existing social agencies, and establishes help with new organizations when needed.

#### ☐ Water Service Committee

The Water Services Committee members will evaluate foundation grant requests relating to waterways & bodies of water within and/or contiguous to the U.S. The committee leadership will present recommendations to the FAC. This committee may meet 6-8 times during the year.

#### ☐ Foundation Advisory Committee

The FAC plays a key role in administering and providing the final steps of due diligence in our grant making process. This committee serves as the platform to hear and review each grant request presented by each chair or vice chair of the service committees. Together, members decide and recommend which grants will move forward for final approval from the Club Board and Foundation Trustees. The FAC is comprised of each service committee chair, vice chair, a foundation trustee, and members at large. Overall it is not anticipated that this committee would consist of more than 20.

#### ☐ Finance/Audit Committee

This Club committee works directly with the president and executive director to develop a comprehensive annual budget for the Club, makes recommendations for policy & procedure surrounding financial record-keeping & processing. The committee reviews the annual audit in September. The finance committee meets quarterly or as called upon to review the budget.

#### ☐ Membership Engagement Committee

This Club committee engages members in activities outside of the Monday meetings with emphasis on new members. Included in these activities would be developing ones around retention and mentoring. This committee orchestrates a fun annual membership campaign, complete with team captains and competition to bring your team spirit to these meetings. Committee encourages current members to seek and propose new members.

#### ☐ Program Committee

This Club committee prepares & arranges programs for all Club meetings. The Program committee meets quarterly to review submitted ideas & speakers and determine the viability of speakers. Members vote to approve or deny which speakers will become part of our Monday program meetings.

#### ☐ Strategic Planning Committee

The Club's strategic plan provides a road map for our Club into 2017. Be a part of the exciting process as our Club members work together in the implementation of our Clubs transformational project(s) funded by our foundation.
