

### Monday's Meeting August 15, 2016:



### District Governor, Do Nguyen

Do Nguyen was born in central Vietnam and attended school in Quang Tri province. In 1974, he traveled to the United States and attended college at Bowling Green University. Unable to return to Vietnam when the new government took over in 1975, the newly married Do struggled but was finally reunited with his wife and infant daughter in the U.S.

After settling in northern Ohio, Do started several small businesses, became active in community affairs. Do joined Maumee Rotary in March 1995. In 1998 he was invited to follow leaders of Maumee Rotary club to Matzatenango, Guatemala to evaluate & dedicate an orphanage for sexual abused girls which was built through a RI matching grant. He later returned to Guatemala two more mission trips with fellow Maumee Rotarians.

In June of 1999, Do followed the late Past District Governor Chuck Oswald & some other Maumee Rotarians on a fact finding trip to Vietnam & attended his first Rotary International Convention in Singapore. In January 2000, along with PDG Chuck Oswald, PDG Chuck Stocking, Vietnam Veterans and other Rotarians, they formed The D.O.V.E. Fund, a nonprofit 501c(3) organization to do charity in Vietnam. The DOVE Fund has since built 50 schools, 4 medical facilities, 3 water systems, 150 latrines many other humanitarian projects Vietnam. In Feb 2002, Do participated in a RI delegation to Vietnam led by PRIP Richard King & PRIP Gary Huang to introduce Rotary to Vietnamese government officials & Do was in charge of distributing 100 wheelchairs to the disabilities in Vietnam for the delegation. At the RI convention in Osaka, JAPAN in 2004, Do met with fellow Rotarians from Mongolia & learned that Mongolia hospitals were in need of used medical supplies. This meeting led to his first trip to Mongolia with Ron Stoner of MESA (Medical Equipment and Supplies Abroad), in 2005 and a container of medical supplies was sent to Mongolia afterward. During Do's term as President of Maumee Rotary club. 2004-2005, they celebrated centennial year with many international projects in Honduras, Guatemala and Vietnam. Maumee Rotary Centennial Pavilion with a hexagon shape on a Rotary wheel was also built in Maumee Site Cut Park

Do was selected as GSE team leader for South Korea in 2011. He also visited Cambodia 3 times in 2011, 2012, and 2013 for setting up, monitoring and evaluating a matching grant to provide water, sanitation and health education training for an elementary school in Siem Riep, Cambodia.

As of today, Do has attended two Uniendo Conferences and 9 RI conventions. Do & Theresa have been married for 44 years. They have 2 daughters and 3 grandsons.

Josh Knights lives by the "Green Rule" - We depend on conserved lands and waters in many ways. The more that we as a society do to harm nature, it will eventually come back to affect us. If we

take care of nature, it will enrich us.

From 1890—1920, thousands of miles of ditches were dug in order to drain the Black Swamp, where we now live. We drained or filled over 90 percent of more than 11 million acres of wetlands, which once helped to purify the fresh water in Ohio.

The bounty of water in Ohio comes to us via streams, ground water and lakes. The wetlands are a natural filter for the water, slowing it as it runs through, allowing sediments to weed out. The loose meandering in streams help slow down the water and help filter it as well. We now have more manmade ditches than streams, without any of the twists and turns.

Because we have depleted so much of our natural water purification system, our fresh water sources are in despair. One of the biggest threats to Lake Erie are the toxic algae blooms. Phosphorus runoff from farms is considered one of the main contributors to feeding this harmful algae. While the wetlands are a great natural filter, they can't clean all of the phosphorus from the water. The best way to improve our water supply is to work with the farmers to reduce the amount of fertilizer that runs off their fields into the water.

The Nature Conservancy has lined up funding to restore wetlands in western Lake Erie and in northeast Ohio. While it would take over 100,000 acres of wetlands to fix the water quality problems of Lake Erie, Knights says that every little bit counts.

By conserving and restoring wetlands, we will help improve the environment in many ways. We'll have cleaner water, more nurseries, habitat for wildlife and ultimately as the "Green Rule" states, a more enriched society as a whole.



Each Rotary year has three grant deadlines:  July 31, October 31, and March 31  Each service committee participates in the due diligence process of vetting each grant. Due diligence invites Club members to review the grant application to determine if it meets our mission as well as the foundation's grant giving criteria. Participation at this level offers an	Vocational Service Committee  Vocational Service Committee members play an integral role in mentoring youth and adults in their respective vocations. Committee members focus on development of professions, trades, and education within the community's chosen vocations. As a Vocational Service Committee member, you will have an opportunity to review and manage grant requests for new and existing vocational programs; this committee has 6-8 meetings per year. Vocational Service provides an
opportunity to truly experience and understand how member contributions impact our community and participate in determining where funds are directed. Committee members decide which grants meet the criteria for recommendation. Each service committee chair &	opportunity to showcase member career skills while participating in mentoring opportunities as well as the promotion & education of the application of the 4-way test in all vocations, at any age.

Community Service Committee  As a member of Community Service, you have an opportunity to participate in the review of grant requests from a broad section of our community. This committee meets 6-8 times/ year to review and discuss grant requests and projects impacting our local community. Non-profits we have supported in the past include the Cherry Street Mission, Sunshine, Habitat for Humanity, Toledo Ballet, Little Sisters of the Poor, Toledo Area Humane Society and many more. This committee spearheads annual service projects such as Salvation Army bell-ringers and a spring clean-up for Little Sisters of the Poor. Involvement with the Community Services Committee offers hands-on opportunities that make a difference right here in our own community.	The Youth Services Committee members have an opportunity to experience and manage multiple grant requests that impact the youth in our immediate area. Past Youth Service grant requests have come from Claire's Day, Toledo School for the Arts, Early Childhood Development & more. This committee will manage grant requests during each of the grant cycles, participate in site visits, and make recommendations to their committee for projects they feel will have the greatest impact, meeting 6-8 times during the year.
