

Monday's Meeting November 6, 2017 Rotary on the Road Robb Voyles *Halliburton*

Robb L. Voyles is Executive Vice President, Secretary and General Counsel of Halliburton Company and a member of the Company's Executive Committee. In his role, he advises the Chief Executive Officer and Board of Directors on corporate governance and legal matters. From March 2017 through June 2017, he also served as the Company's Chief Financial Officer.



Before joining Halliburton, Mr. Voyles was a senior partner at Baker Botts LLP, where he served as global chair of the Litigation Department and as a member of its executive committee. His practice focused on commercial, securities, and Foreign Corrupt Practices Act litigation and investigations. He represented major accounting and law firms in professional liability litigation, as well as major corporations in commercial, securities, and technology litigation and government investigations.

Mr. Voyles is a member of the Board of Directors of Jones Energy Inc. He is chair of the Nominating and Corporate Governance Committee and a member of the Audit and Compensation Committees.

Mr. Voyles holds a Juris Doctor from University of Michigan Law School and a Bachelor of Business Administration from University of Dayton in Ohio. He is a member of the State Bar of Texas and the American Bar Association, and he is a Fellow of the Texas, Dallas County, and Travis County Bar Foundations.

Toledo Rotary Club Foundation

Thanks to your generous donations to your Toledo Rotary Club Foundation, the following 1st cycle grants were recently approved for funding:

Community Service Committee:

Catholic Charities Diocese of Toledo—\$5,400 for purchasing 20 replacement mattresses, protector pads and bedding for La Posada Family Emergency Shelter.

Kids Against Hunger Food Pack—\$7,500 for purchasing and packing 25,000 nutritious meals to be given to impoverished children and families.

Disability Service Committee:

Zoo Day—\$3,081.15 for Zoo Day with Glendale Feilbach School and St. Francis Interact students. The grant provided a day of fun, t-shirts and lunch at the Toledo Zoo.

International Service Committee:

International Service Fellowship—\$5,000 to subsidize costs to participate in a hands-on international Rotary project, or to visit a Toledo Rotary grant project reviewed by the International Service committee.

UT Foundation—Engineers Without Borders Irkaswaa Water Project—\$10,000 for the development of a well, construction of a generator storage house, standpipes for water access, and troughs to water animals in Irkaswaa, Kenya which suffers from an extreme water crises.

Vocational Service Committee:

565 Academy—\$3,000 to pay the \$150 per child for a one hour gym class and one hour swimming class every Friday for the school year, for children whose families are not able to afford the cost.

Toledo Rep Theatre—\$6,800 to update the sound and lighting equipment for the Young Rep.

Water Service Committee:

UT Foundation Harmful Algae Project—\$10,000 for the College of Engineers to develop an unmanned boat to monitor and collect harmful algae in Lake Erie.

The Andersons is founded on the belief that all of us are subject to a higher and divine authority, and that we should aspire to goodness, integrity, fairness, respect and those virtues which we think are consistent with divine will. They place constant and primary focus on

their customers and the community. In the spirit of giving, and the ideals The Andersons share with Rotary, Pat Bowe announced they were giving a donation to the Toledo Rotary Club Foundation Polio Plus Fund. The Andersons has 2,000 employees and 100 plus locations. They started with the grain business, buying and selling with local farmers, which then linked them to other areas. The Andersons operates four ethanol plants, collectively capable of producing 330 million gallons of ethanol, their largest partner being Marathon Petroleum—the largest ethanol consumer in the US. Plant nutrients is their fertilizing business, they built this group based off of their grain business. They sell to other retailers, customers and also farmers. The Andersons is one of the largest suppliers of specialty fertilizers to golf courses. The last group the Andersons takes part in is rail. They transported their grain and fertilizer in through rail, and decided to make it part of their business. The rail group provides a variety of services to the rail industry, including fleet management, leasing, repair and custom fabrication. They now have 23,000 rail cars—and they are not all for transporting grain and fertilizer.
