



Monday's Meeting: May 14, 2018 Isaac Schiefer & Julia Faulkner Pechlivanos *Local Efforts to End Alzheimer's*



Dr. Schiefer's lab carries out research in two areas at the interface of medicinal chemistry and chemical biology:

- 1) small molecule hit-to-lead optimization- using synthetic, bioanalytical, and bioorganic chemistry
- 2) target identification using techniques in chemical and cellular biology

He and his team are interested in creating and developing novel therapies for neurodegeneration, with an emphasis on Alzheimer's disease (AD). Their primary long-term objective is to translate SAFE and EFFECTIVE novel small molecule therapies into the clinic to improve patient outcomes and human health. His current work involves the development of attenuated nitric oxide (NO) mimetics as novel therapeutic candidates for stroke and AD. Dr. Schiefer was recently granted \$2 million dollars by the National Institutes of Health to advance his research at the University of Toledo. At the age of 33, he is one of less than 4% of NIH funded researchers under the age of 35. Dr. Schiefer is a native of Bucyrus, OH, and lives with his wife and two daughters in Perrysburg.

Julia Faulkner Pechlivanos has been a member of Toledo Rotary since 1999. She is executive director of the Alzheimer's Association, Northwest Ohio Chapter. The mission of the Alzheimer's Association is to eliminate Alzheimer's disease through the advancement of research; to provide and enhance care and support for all affected; and to reduce the risk of dementia through the promotion of brain health. Julia joined the Alzheimer's Association in May, 2017. The Northwest Ohio chapter serves 24 counties in Ohio.

Your Toledo Rotary Club Foundation Awards \$10,000 Grant!

Your Toledo Rotary Club Foundation recently awarded The Reentry Coalition of Northwest Ohio a grant in the amount of \$10,000. The funds from the grant will be used for bus passes, birth certificate/state ID's, and housing assistance to benefit formerly incarcerated, or individuals at risk of incarceration who had behavioral disorders.

The Reentry Coalition of Northwest Ohio (RCNWO) is a coalition of agencies and service providers whose mission is to provide leadership, build partnerships and promote shared accountability for successful community reentry. RCNWO has been in existence for about 17 years, and received designation as a 501©(3) in 2015.

The goals of RCNWO are to eliminate barriers to successful reentry, reduce recidivism, and promote public safety. The cornerstone of the RCNWO is its "Going Home to Stay" or "First Wednesdays" program which, in conjunction with the efforts of the Northwest Ohio Regional Reentry Officer of the Lima Region Adult Parole Authority, offers monthly opportunities for returning citizens and their families to connect with approximately 20 to 25 service providers. These service providers include volunteer attorneys and Bureau of Motor Vehicle Reinstatement Center representatives to address child support, identification, housing, legal and employment related issues. This program started in 2009, and thousands of formerly incarcerated individuals have already been helped. The RCNWO has Housing, Employment, Legal, Services and Supports Committees, and various ad hoc Subcommittees, which identify reentry programs and initiatives that are needed to expand the opportunities of the formerly incarcerated and to allow them to become productive members of our community, and to prevent them from recidivating.

About 22,000 ex-offenders are released from Ohio correctional institutions annually. One of RCNWO's most innovative programs allows attorneys to visit prisons such as Toledo Correctional Institution, Allen-Oakwood Correctional Institution, and the Corrections Center of Northwest Ohio once a month to work with those offenders due to be released within the next six months. They try to identify legal issues that could get in the way of successful re-entry such as outstanding warrants, fines, license suspensions, and child support issues. Collectively, RCNWO helps identify needs and coordinate services for individuals who might otherwise resort back to crime.



installed free smoke alarms while educating home owners on preparedness and fire safety.



Ulmer's Immigration Law Group



In January 2017, Trump issued an Executive Order, "Enhancing Public Safety in the Interior of the United States," that potentially makes almost every undocumented immigrant a deportation priority. US Immigration and Customs Enforcement started taking actions against long-term residents, many of whom have been in the US for decades, have US citizen spouses and children, and have never been convicted of a crime. Trump wants the 11 million undocumented immigrants out of the US—and their priority levels are all the same. A hard working illegal immigrant with a job and family is ranked at the same priority level of deportation as an illegal immigrant who is a rapist. A lot of the immigrants who are being deported paid their taxes, supported their families, and followed the law. Sanctuary cities do not and cannot offer sanctuary from federal immigration enforcement. Rather, they simply do not expend local resources to take part in it. These "sanctuary cities" are counties, cities and municipalities that do what they're supposed to do; enforce state and local law, allowing local police to focus on community safety.
