




Monday's Meeting: June 25, 2018

Matt Markey is the Outdoors Editor for The Toledo Blade newspaper. He graduated from St. Wendelin High school, and received a degree in journalism from Bowling Green State University. Matt has been at The Blade for 24 years, he has worked for newspapers in Orlando, Bowling Green and Fostoria. Prior to that, Markey worked in the movie business in California, Montana, Utah, Arizona and New Mexico for about 6 years. He has been The Blade's outdoors editor for the past six years, before that he covered Ohio State football and the athletic teams at Michigan, the University of Toledo and Bowling Green State University.

Matt has won numerous awards from the Outdoor Writers of Ohio, Southeast Outdoors Press Association and the Associated Press. His work has won five first place awards, at the recent Outdoor Writers of Ohio annual conference.

Matt's parents, Dr. and Mrs. Stephen Markey, MD of Fostoria, were both US Army World War II veterans. Matt's mother, First Lieutenant Helen L. Matthews Markey, is buried in Arlington National Cemetery.

He is working at a Northwestern Hospital downtown Chicago this summer in the marketing department. In the fall quarter, Aiden will intern at Instagram in New York City. Aidan was a 4.3 GPA student in high school, senior class president, all-district varsity basketball player and all-league academic team.

Awards \$5,400

Your Toledo Rotary Club Foundation recently awarded a grant in the amount of \$5,400 to the Catholic Charities La Posada Family Emergency Shelter. The funds were used to replace mattresses and protector pads for the shelter as well as bedding and comforters. The number of replacement mattresses purchased provides a safe, hygienic environment for new admissions to La Posada and reduces cash outlays from other sources that have been used for direct client needs, such as food, hygiene needs, and transportation. Changes in bedding and possibly mattresses, if there are any issues, for every new resident admitted to the shelter can become costly. Since December, La Posada has served over 84 individuals in 26 households.

La Posada Family Emergency Shelter offers temporary housing and supportive services to homeless families of all faiths and backgrounds in the Toledo area. Direct services through La Posada include shelter, food, clothing, personal hygiene products and case management.

Catholic Charities' staff empower families to achieve self-sufficiency through programs that help them identify goals and build on their strengths to attain them. By providing shelter, supportive resources and linking people to resources in the community, Catholic Charities helps vulnerable families achieve stable housing and become self-sufficient.

Since its opening nearly two decades ago, La Posada has provided shelter to more than 2,000 families.

The name La Posada originated from the Spanish holiday, "Las Posadas." The event is a nine-day celebration that represents the difficulties that Joseph and Mary, the mother of Jesus, faced in search of a room when traveling to Bethlehem.

Groups of children and adults go from house to house singing a traditional song requesting lodging (posada). At each house, the owner responds with refusal until Mary and Joseph reach the designated site for the party. The owner, or "innkeeper", recognizes Joseph and Mary and they are finally allowed in. Today, Latin American countries continue to celebrate this holiday.

Catholic Charities' La Posada Family Emergency Shelter was initially established to serve the Hispanic community but now serves all families in need of a place to stay.

Did You Know?

The first motto of Rotary International, "He Profits Most Who Serves Best," was approved at the second Rotary Convention, held in Portland, Oregon, in August 1911. The phrase was first stated by a Chicago Rotarian, Art Sheldon, who made a speech in 1910 which included the remark, "He profits most who serves his fellows best."

At about the same time, Ben Collins, president of the Rotary Club of Minneapolis, Minnesota, commented that the proper way to organize a Rotary club was through the principle his club had adopted "Service, Not Self." These two slogans, slightly modified, were formally approved to be the official mottos of Rotary at the 1950 Convention in Detroit- "He Profits Most Who Serves Best" and "Service Above Self."

The 1989 Council on Legislation established "Service Above Self" as the principal motto of Rotary, since it best explains the philosophy of unselfish volunteer service.

MEMBER IN THE NEWS!

The Silver Beaver Award was introduced in 1931, and is the council-level distinguished service award of the Boy Scouts of America. Recipients of this award are adult leaders who have made an impact on the lives of youth through service given to the council. Candidates for this award must be nominated, and given to those who implement the Scouting program and perform community service through hard work, self-sacrifice, dedication, and many years of service. It is given to those who do not seek it. Five Silver Beaver awards were presented this year during a ceremony at the Toledo Club Thursday, June 7th, including one to Rotary Club of Toledo member James W. Layman.



Ford Bennett

Deployment & Tour of Duty



“Professional at minutiae”. That’s what marine’s have to be. While training for Afghanistan, Ford and his team of 17, would do the easiest and simplest of tasks over and over again to perfection. To be sure they could do it properly in the chaos of a real situation, they had to have it perfect in a training environment. Ford’s job in the field command unit was to go over battle field coordination, command and control. He was to make sure all units worked in harmony and work as the central hub for information and ensure communication flowed efficiently. During training, they would run around with 40lbs of gear on their bodies and carrying each other on stretchers in extreme heat. The idea is while they’re out on their own and they are under extreme circumstances, they will be able to get their fellow marine’s home. In Germany, Ford and his team trained for counter-IED’s, casualty evacuation drills and more. The training included simulated gunfire and warfare—the US Army can even turn up and down the intensity of the simulation based on the soldiers performance. Their idea behind that is “the more you sweat and bleed in training, the less you sweat and bleed in the war”. In Afghanistan, their mission was to train, advise and assist the Republic of Georgia to fight and win. The hope is that one day they will be able to take on that mission on their own and continue the fight against Al-Qaeda.
