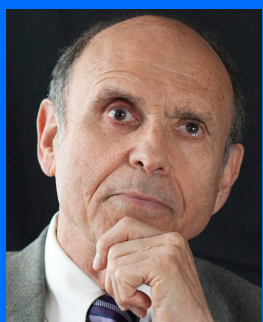

**SAMUEL ADLER,
COMPOSER**

**BUILDING BRIDGES
THROUGH MUSIC**

Samuel Adler was born March 4, 1928, Mannheim, Germany; he came to the United States in 1939. He was inducted into the American Academy of Arts and Letters in May 2001 and the American Classical Music Hall of Fame in October 2008.

He is the composer of over 400 published works, including 5 operas, 6 symphonies, 12 concerti, 9 string quartets, 5 oratorios, and many other orchestral, band, chamber and choral works and songs which have been performed all over the world.

Adler was educated at Boston and Harvard Universities and holds many honorary doctorates. In addition, he has been awarded many prizes, one of which was in May 2003 when he was presented with the Aaron Copland Award by ASCAP, for Lifetime Achievement in Music (Composition and Teaching).

Adler has appeared as conductor with many major symphony orchestras, both in the U.S. and abroad.

International Services Grant Paired Kidney Donor

Rotary Club of Toledo's International Services committee approved a \$5,000 international grant to assist in a kidney transplant that would take place in Rome with a paired donor from the U.S. This ground-breaking process was featured in Newsweek, April 14, 2017—see insert below. International Services committee chairman Mike Noble, reached out to the district governor and Toledo Rotary to make the necessary connections in Rome. The results were fantastic as Dr. Rees connected with former club member, board director and past President of the Sisters of Notre Dame, Sr. Mary Ann Culpert, a kidney donor herself.

"CHAIN OF LOVE"

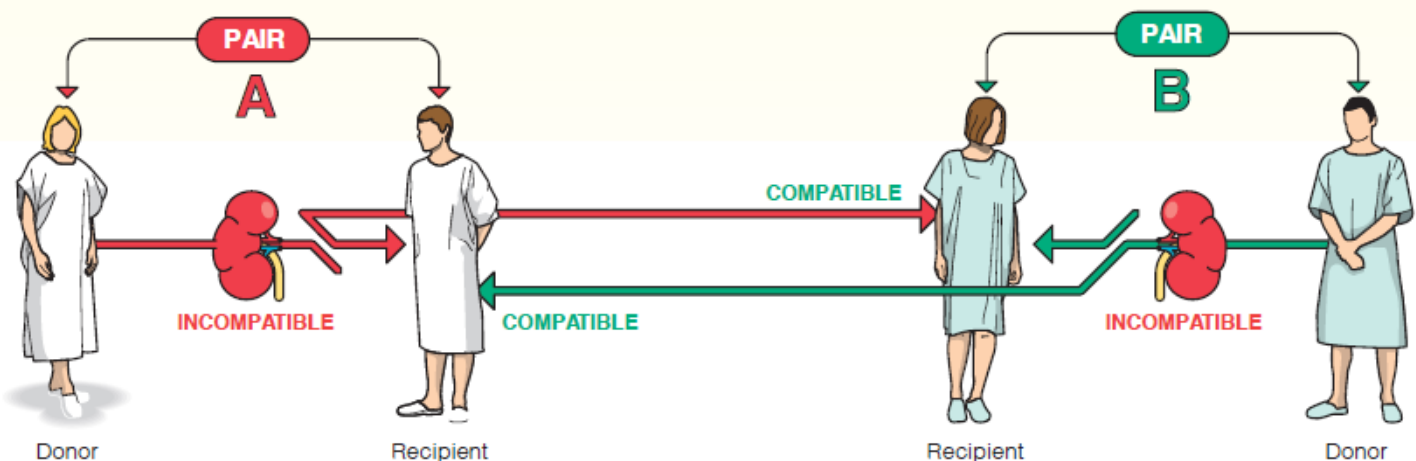
The theory developed by Alvin Roth and his team was masterfully implemented by Michael Rees. The surgeon and his wife, Susan, set up a chain of donors and recipients where participants committed to exchange organs in a non-simultaneous manner. Through years of work with kidney sufferers, the couple knew that potential donors would fulfill their part in the exchange once they experienced the gratitude of a family at receiving an organ that could save the life of their patient. So, for the first time in history, the guarantee in the process of organ exchange would no longer be simultaneous delivery but mutual trust; even if direct participants never met.

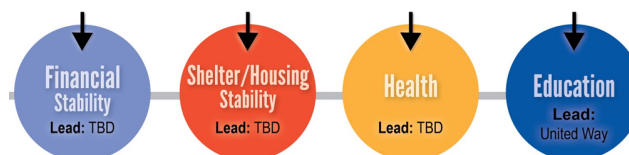
The outcome is a finalized strategy, United Way Moving Forward, Uniting the Caring Power of People to Improve Lives.

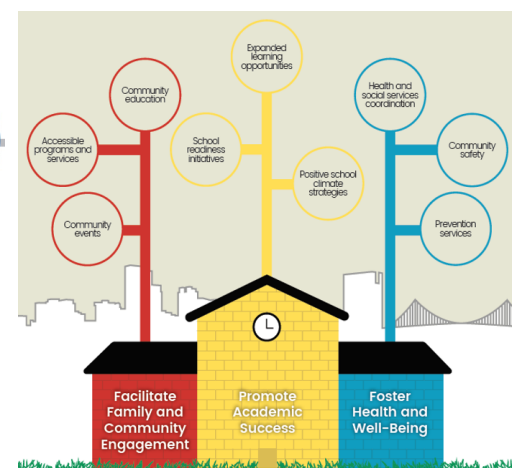
