The County Executive has also made economic development a major priority through the development and implementation of his economic roadmaps, the "Initiatives for a Smart Economy". The original report (released in June 2013) and its Initiatives 2.0 version (released in June 2017) provide evolving blueprints for comprehensive, innovative economic development that brings partners together to leverage strengths across Erie County. Together the two plans encompass over 130 target areas for economic development, focusing on land development and re-development, international business attraction and trade, energy, tourism, agriculture, workforce development and more.


