Dr. Cheryl McCullumsmith, UTMC SAVING THE WORLD: Overdose, Suicide & Covid-19



This Monday please join us when fellow Rotarian Dr. Mccullumsmith from UTMC will address the ground breaking community based research on opiods, suicide and Covid-19 being conducted at the University of Toledo Department of Psychiatry.

As Professor Director, Consultation Liaison Service and Chair, Department of Psychiatry at UT, Cheryl has spent years researching the study and treatment of mental illness, emotional disturbance, and abnormal behavior which can be applied to the mental effects from the Coronavirus. She is qualified to assess both the mental and physical aspects of psychological problems resulting from "Shelter in place" as well as the death threat of the rapidly spreading virus.

Dr. McCullumsmith began her studies at the Massachusetts Institute of Technology, Cambridge, MA, in 1989 where she received her Bachelor of Science Physics degree. At the University of Michigan, she received her Neuroscience PhD in 1999 followed in 2007 by her MD with Honors in Research. During this time, she also received her Psychotherapy Training Certification from the Michigan Psychoanalytic Institute, a premiere training institute for psychoanalysts in the United States.

Dr. McCullumsmith lives in Sylvania and has five children including a set of triplets!



GIRL SCOUTS OF WESTERN OHIO

Area Girl Scout troops have lost an average of \$900/each in sales which were to be used to support their goals and activities because they have been unable to complete to their cookie campaigns. Girl Scouts of Western Ohio, is projecting a \$1 million loss their largest annual revenue source. This will impact the services they areable to provide to over 37,000 girls – things like financial aid for girls to attend camp, training for troop leaders, and valuable online resources for volunteers. MONDAY, **APRIL 6TH RECAP US SENATOR** SHERROD BROWN

Since January of 2007, U.S. Senator Sherrod Brown - a champion of middle-class families in the Senate – has held more than 300 community roundtables across Ohio's 88 counties with students, local leaders and business owners, entrepreneurs and educators, workers and families to find ways to rebuild our economy.

Senator Brown shared the most up to date information regarding the Coronavirus Pandemic. The Senator discussed small business opportunities during COVID-19 as well as issues surrounding testing and PPE's for our local health care workers. Senator Brown addressed questions about the Paycheck Protection Program and about the Economic Injury Disaster Loan programs offered through the Small Business Administration during the Coronavirus crisis. During our Zoom meeting, Rotarians were afforded the opportunity to speak very candidly with the Senator about issues surrounding this unprecedented international crisis.

Described as "Congress' leading proponent of American manufacturing," Brown supports a national manufacturing policy that would invest in manufacturing innovation, strengthen our component supply chain, connect workers with emerging industries, and align our trade policies to promote our national interests. He is also working with Ohio's universities, entrepreneurs, and community stakeholders to use Ohio's resources to create new jobs in high-growth industries and make Ohio a national leader in clean energy manufacturing

Prior to serving in the United States Senate, Brown served as a United States Representative for the 13th District, Ohio's Secretary of State, a member of the Ohio General Assembly, and has taught in Ohio's public schools and at The Ohio State University. An Eagle Scout, Brown is a native of Mansfield, Ohio, where he spent summers working on his family's farm. He is married to Pulitzer Prize-winning columnist Connie Schultz. They reside in Cleveland, Ohio, and have three daughters, a son, a daughter-in-law, three sons-in-law, and seven grandchildren.
