Robert Baxter President, Mercy Health North Bon Secours Mercy Health

Bob Baxter is the President of Mercy Health North for Bon Secours Mercy Health, the largest health system in Ohio. As a leader in Northwest Ohio, Baxter oversees strategy and operations for eight hospitals, one college, and more than 100 sites of care across Northwest Ohio and Southeast Michigan. The Northwest Ohio Markets employ more than 5,500 staff and 400 providers, experiences more than 47,000 admissions, and has net operating revenue of greater than \$1 billion.

Baxter previously served as the President and CEO, St. Rita's Health Partners and Senior Vice President, Mercy Health which included two hospitals, four physician joint ventures and a wholly owned physician enterprise. Prior to joining Mercy Health, Baxter served as the Chief Operating Officer at Rapid City Regional Hospital in South Dakota.

He received his bachelor's degree from The University of South Dakota in Vermillion, South Dakota. He received a MBA and a MA in Hospital and Health Administration from The University of Iowa.

Baxter is a member of the Board of Directors for the Ohio Chamber of Commerce, Regional Growth Partnership, United Way of Greater Toledo, and Connect Toledo Downtown Development Corporation. He previously served as a delegate to the American Hospital Association (AHA) Regional Policy Board, a member of the ACHE Chapters Committee, President of the South Dakota Healthcare Executive Group, and received the ACHE Early Career Healthcare Executives Regent's Award.



ROBERT SPRAGUE TREASURER STATE OF OHIO



Robert Sprague currently serves as Ohio's 49th Treasurer. Prior to becoming Treasurer, he served the 83rd District as a member of the Ohio House of Representatives from 2011 through 2018.

In his current role, he oversees the State's investment and debt portfolios, domestic and international custody portfolios, and annual cash movements and deposits. Treasurer Sprague remains committed to improving Ohio and the lives of its residents through trusted stewardship, wise investment and bold innovation. These principles have been at the forefront of his work since taking office in January 2019.

On Monday, Sprague presented to our club about the initiatives the Treasurers Office is implementing to assist businesses and organizations during the COVID-19 crisis. One of the items he discussed was the Ohio Treasurer's assistance provided to hospitals in preparing and handling COVID-19. The Treasurer stated they helped save the hospitals over \$10,000,000 dollars. In addition, his office is working in tandem with the federal government to promote the Payroll Protection Program (PPP) which is providing forgivable loans to small businesses while they are mandated to be closed.

Treasurer Sprague's commitment to strong fiscal stewardship and public service first took root in his hometown of Findlay. Prior to entering state government, he served his local community as both city auditor and treasurer. In these roles, he balanced city budgets, and helped finance a massive recovery effort after historic floods and the 2008 economic recession. While in the private sector, Treasurer Sprague was a project lead at Ernst & Young and worked on a number of high-profile engagements with Fortune 500 companies before forming his own consulting firm.

Treasurer Sprague graduated from Duke University with a bachelor's degree in mechanical engineering and later earned a master's degree in business administration with an emphasis in finance from the University of North Carolina, Chapel Hill. He and his wife Amanda live in Findlay with their five children.
