Welcome 2020-2021 Toledo Rotary Club **Foundation Trustees**

The Rotary Club of Toledo, established in May 1912, created a charitable fund by 1915 when it began funding medical and educational services directed to crippled children in the Toledo area. The charitable activities of the members of the Rotary Club of Toledo have a 100-year history! The Toledo Rotary Club Foundation funds two types of grants: Traditional and Transformational. Since our 2012 Centennial, the Toledo Rotary Club Foundation has funded 110 non-profit groups for a total of \$692,583.16. Last year alone the Foundation funded 27 grants totaling \$197,998.15! Ongoing funding for the Toledo Rotary Club Foundation comes from Rotarians and community members. These dollars go directly to the charitable gifts the Foundation awards throughout the year. Over \$200,000 is awarded annually through grants.

2020 - 2021 Grant Information and Deadlines

The Rotary Club of Toledo offers two types of grants: Traditional and Transformational. Traditional grants are most common and are awarded in three cylces. Deadlines for Traditional grants are July 31st, Oct. 31st, and March 31st. Since Transformational grants are awarded less often, contact the Rotary Office before applying to see if the Rotary Foundation will be funding any new transformational projects for the upcoming year. Traditional Grants:

Traditional grants are the most common grants funded, and typically each year the Toledo Rotary Club Foundation funds approximately \$200,000 in grants. The Toledo Rotary Club Foundation funds grants exclusively to nonprofit, 501(c)3 tax-exempt organizations.

Transformational Project Grants:

A Transformational Project is one that: Affects abroad sector of the community (local, regional or global); has the overwhelming support of the Rotary Club of Toledo and has been designated and approved by the Club Board and Foundation Trustees; is likely to be a multi-year commitment and has sustainable goal of making a significant, long-term, positive impact.

ADAM LEVINE DIRECTOR TOLEDO MUSEUM OF ART


Toledo's Museum of Art: Past, Present, and Future.





The Toledo Museum of Art (TMA) has appointed a familiar face to the Toledo area arts community, Adam M. Levine has been chosen to step in as the next Edward Drummond and Florence Scott Libbey director of the Museum. Levine returned to TMA May 1st from the Cummer Museum of Art & Gardens in Jacksonville, Florida, where he was the George W. and Kathleen I. Gibbs Director and Chief Executive Officer. While there, Levine raised more than \$11 million and increased attendance and membership by 20 percent. Prior to his post at the Cummer Museum, which began in October 2018, Levine served in several roles at TMA since 2013, most recently as deputy director and curator of ancient art. Levine graduated summa cum laude and Phi Beta Kappa from Dartmouth College, where he majored in anthropology, art history and mathematics & social science. He continued his studies as a Rhodes Scholar at the University of Oxford, where he earned his master's degree with distinction and Ph.D in the history of art. He publishes widely and is a frequent presenter on topics ranging from ancient art and interpretive strategies to museum and management practices. On the personal side, Adam states "I live in Toledo with my fiancée, Brooke, and 7-year old, Chase, who will be a second-grader at Maumee Valley Country Day School. My hobby, alas, is work at this stage in my life, but the most surprising thing to most people seems to be that I was a Golden Gloves boxer and boxed for Oxford while there."


