# Burt Logan Executive Director/CEO

**Ohio History Connection** 

#### **Northwest Ohio Historic Sites**

Burt Logan will provide an overview of the Ohio History Connection with special emphasis on the historic sites located in NW Ohio. He became the Executive Director and CEO of the Ohio History Connection (formally the Ohio Historical Society) in December of 2009. The Ohio History Connection is a private, nonprofit organization established in 1885 serving as the state's partner in preserving and interpreting Ohio's history, archaeology and historic architecture.

Prior to moving to Columbus, Mr. Logan led the U.S.S. Constitution Museum from 1995 to 2009—first as Executive Director, then as President since 2007. From 1986 to 1995, he served as the Director of the Wisconsin Maritime Museum in Manitowoc, Wisconsin. He began his museum career as Executive Director of the Wyoming Historical and Geological Society in Wilkes-Barre, Pennsylvania from 1983 to 1986.

He received a Bachelor of Science degree from the United States Military Academy at West Point, New York in June 1976. In his senior year, he was awarded the General of the Army Omar Nelson Bradley Award for Excellence in Historical Research and served as an officer until 1981. In 1983, he received his Master of Arts in History Museum Studies from the Cooperstown Graduate Program. In 2005, he attended the Museum Leadership Institute at the Getty Center in Los Angles, CA.

He and his wife Bonnie live in Bexley, Ohio and are the parents of three sons, Mark, Garrett and Sean and the grandparents of Corrin.



Rotarian Tim Harrington, is the Executive Director of The Ability Center and on Monday, he shared the story of the evolution of the Ability Center, which was made possible by Toledo Rotary 100 years ago!

The Ability Center originally started as the Crippled Children's Home. Over time, our community needs changed as did the services offered by the Center. Today, the programs promote independence and community living.

Tim informed members and guests of the aray of resources available at the Ability Center for those with disabilities as well as resources for employers and individuals working to make our community disability friendly. The Ability Center has a tool kit available that is shared with business, government, media and more for use in the implementation of a disability friendly atmosphere with easily followed policies. The Ability Center's vision is for Toledo to become *the most disability friendly community in the Country.* The original mission and intent of Toledo Rotary continues today and on December 10th, 2020, the organization turned 100!
