Laura Koprowski brings 25 years of transit and transportation experience to her role as Chief Executive Officer of the Toledo Area Regional Transit Authority (TARTA). The Toledo native came home to work for TARTA in April of 2020 after serving as Executive Director of the Ohio Public Transit Association. She has a history successfully executing innovative transit projects, including the Central Ohio Transit Authority's bus system redesign and deployment of microtransit service. While at TARTA, Laura led the implementation of TARTA's Vaccine Mobile and a new focus on economic development and workforce transit solutions.

In less than two years at TARTA, Laura has helped to oversee sweeping organizational changes, leading to dramatic improvements in efficiency, customer experience, and community relationships. Most notably, she was instrumental in the success of TARTA's Issue 12 campaign, which changed TARTA's funding structure to a sales tax, expanded its service area to all of Lucas County, and set the Authority up to fund badly needed, long-term improvements.

As a public relations expert and a skilled project manager, Laura has helped transit agencies around Ohio overcome significant challenges and meet and exceed their goals. She looks forward to continued progress at TARTA which, under her direction, continues to transform itself into the forward-thinking and effective transportation option that the people of the Toledo Metropolitan area need and deserve.

Laura is a member of the Board of Directors for the Ohio Public Transit Association and the Legislative Committee of the American Public Transportation Association. Locally, she represents TARTA on the TMACOG Board; is a member of the Toledo-Lucas County Sustainability Commission; and is co-chairing the transportation working group for the Junction McClinton Nunn Choice Neighborhoods Plan. Laura earned a Masters in Public Administration from Bowling Green State University and Bachelors of Art in Political Science from Ohio University. She is a 2020 graduate of Leadership Ohio and currently serves as an ambassador for the statewide organization.


